## ORDER

Sub: Appointment of "Returning Officer" and the "Election Programme" for Conduct of Elections of the Bihar State Cooperative Marketing Union Ltd, BISCOMAUN

In exercise of the powers conferred by Section 45 K (1) of the Multi-State Cooperative Societies (MSCS) Act 2002, as amended by the MSCS amendment Act 2023 read with Rule 19F (a) of the MSCS Rules 2002, as amended with MSCS Rules in 2023, the Co-operative Election Authority hereby appoints District Magistrate/Collector, Patna as Returning Officer for conducting Elections as under:

- 1.1 RO may submit proposal for appointment of adequate number of ARO.
- 2. The Constituency shall be as per registered and approved Bye-Laws of the Society.
- 3. Further, in view of Rule 19(H)(2) of the MSCS Rules 2002 as amended in 2023 with MSCS Rules as 2023, the Election Programme for conducting election of the aforementioned Society is enclosed for further necessary action. RO is requested to ensure the election is conducted as per the MSCS Act, 2002 and Rules framed thereunder.
- 4. After conduct of Elections of Board of Directors, the RO is mandated to submit the requisite details in Format 19 M (for members of the Board of Directors) under rule 19 M for seeking prior approval of the Co-operative Election Authority.
- 5. After conduct of elections of Office Bearers, the RO shall submit the requisite details in Format 19-N for seeking prior approval of CEA before declaration of results.
- 6. Returning Officer shall ensure that the Society prominently displays the List of Eligible Voters, Election Programme and Final List of the Contesting Candidates, and other related important documents on the website of the Society for enabling free, fair and transparent elections.

- 7. Wide publicity be given for holding of Elections in terms of provision of the MSCS Act and the rules framed thereunder.
- 8. Instructions for filling-up of the Format- M and N have been appended below the Format M and N, the same should be scrupulously followed by the Returning Officer.
- 9. In order to conduct free & fair election of delegates at district level, it has been decided by CEA under Rule 19F (a) to conduct election under the supervision of state / Central Government Officers. Therefore, RCSs of both the States are requested to deploy serving District Cooperative Officers or any other competent serving officer of equivalent rank posted in the district for conducting the delegate elections under intimation to DM & RO, Patna. Such officers shall work under the general superintendence & control of DM, Patna for the purpose of conduct of delegate elections


